The following Article(s) in the Partnership Terms are revised and supplemented as follows:

#### Article 2 (Working Together):

Engagement with Government. This partnership is being executed in furtherance of the Global Compact on Refugees (see General Assembly resolution 73/151). UNHCR will engage with the Government in accordance with the Government's mandate, including in matters agreed between the Government and UNHCR related to the planning, monitoring, evaluation or follow up on matters pertaining to its operations and the operations of its Partners, including this Partnership and any Project Workplans that will be entered into between UNHCR and the Partner under this Agreement.

#### Article 3 (General obligations):

<u>Obligations of the Government</u>. The Government agrees, in accordance with Article 2(5) of the UN Charter, to give every assistance to facilitate any project implemented by UNHCR, including in relation to this Agreement, to:

- to take reasonable steps to ensure that UNHCR and Partner Personnel receive all support and facilities necessary for the speedy and efficient execution of any Project implemented by UNHCR and the Partner pursuant to this Agreement, and
- to facilitate the process described under Article 14 under the heading "UNHCR's ownership of Intellectual Property".

#### Article 18b (Conflicts of interest):

Conflicts of interest. Each of the Parties undertakes:

- that neither it nor its personnel have been or will be offered any direct or indirect benefit arising from the Agreement,
- to inform its personnel that they must refrain from conduct which may be perceived as a conflict of interest, or is incompatible with the aims and objectives of the United Nations or mandate of UNHCR, and
- to bring any potential conflicts of interest to the attention of the Parties immediately.

#### Article 25 (Termination):

UNHCR will engage in prior dialogue with the Government before initiating termination for the reasons described as "Additional grounds".
