Benefits of the UN Partner Portal

Partnership Opportunities

- UN agencies can post *Open Selection* partnership opportunities in a central public location that is accessible to all prospective partners
- Civil society partners can submit applications for partnership online which will be reviewed by UN agencies using the Portal
- UN agencies can alert specific civil society partners of *Direct Selection* partnership opportunities
- Civil society partners can submit Unsolicited Concept Notes for review by UN agencies

CSO Profiles

- Civil society partners can create profiles that highlight their mission, expertise, contacts, operating locations and key documents
- UN agencies can learn about a broad range of prospective civil society partners, including both those new to the UN and those with prior UN experience
- Key documentation uploaded by partners on their profiles is accessible to UN agencies and reduces the duplication of requests for documents
- UN agencies can rapidly mobilize partnerships and contact potential partners based on the information included in their profiles

Due Diligence

- Civil society partners complete the required mandatory partnership declaration that is harmonized across multiple UN agencies
- UN agencies are able to conduct due diligence verification of prospective partners, and share the results with other UN agencies
- · Partners are automatically screened against the UN Security Council sanctions lists
- UN agencies share information on partnership risks

Improved Efficiency

- · Reduce timeline for partnership selection and processing
- Increase compliance with UN agency requirements for civil society partnerships
- Civil society partners access centralized resource library with partnership guidelines from multiple UN agencies

CSO Mapping

- UN agencies can map the locations of prospective partners based on operational presence and sectoral expertise
- Partners can be identified for rapid partnership mobilization in humanitarian response and development programming

Partnership Data

- Partners can view their cash transfers from multiple UN agencies in a central location
- UN agencies can extract key partner profile data for analysis
- Generate metrics on partnership practices
